3. Eligibility to enter.

a) Entry is open only to legal residents of Samoa aged 21 years and over ("Eligible Entrants") and excludes tourists visiting the country.

b) Vodafone staff and immediate family (parents, spouses, sisters, brothers & children) are not entitled to participate.

4. Entry into the promotion

a) There are two main entry points for the promotion -

i. Entry can be done using Vodafone's following platforms USSD *888#, My Vodafone app, M-Tala USSD *175#, or other methods.

ii. A customer who purchases a device from the Vodafone online shop via the website, Maua App, or any Vodafone Retail Stores or Roadshow locations. All device sales are either on a cash basis or with financing options available.

- b) Vodafone Prepaid Mobile, Post-paid Capped Mobile & Prepaid Fixed Line customers are eligible for this promotion. One (1) entry point is earned for every tala spent.
- c) Entries will not accumulate between eligibility periods for fortnightly draws. This means that all customer entries will reset to zero for fortnightly prizes.
- d) Date of draw and prize distribution dates are subject to change at the discretion of Vodafone Samoa Ltd.
- e) Only Pure Postpaid customers of Vodafone who have made a cash payment for a device purchase are eligible for the draw.

5.3 If the winner cannot be located. For example, if phone numbers are no longer in use, are not reachable or not taking calls after 3 attempts then a redraw will be done under GCA supervision.

6. Cash Prizes

b) The winning payment will be made via TT/Bank cheque. The customer must have a valid bank account to receive the payment.
